Our safe return to in-person instruction plan directly incorporates CDC recommended mitigation strategies for the safe reopening and operation of our schools. This includes the proper use of masks, supporting our students, teachers, school leader and family community to engage in hygiene practices such as frequent handwashing, and more. Some examples of specific, CDC-recommended strategies outlined in our in-person instruction plan include:

## MITIGATION AND PREVENTION STRATEGIES

#### Universal and Correct Wearing of Masks:

- We continue to require masking indoors for all students and staff working with students following universal <u>CDC</u>.
- Masks will be provided for all students and staff when needed.
  - We follow the universal and correct wearing of face coverings.
- If there is a medical reason a child(ren) cannot wear a face covering, you will need to contact the school office needs to be informed for exemption.

## Physical Distancing, Quarantining & Isolating:

• Teachers are encouraged to use outdoor spaces for instruction as appropriate.

#### Handwashing & Respiratory Etiquette:

Building principal will continue to work with their staff to facilitate:

• Schedules to allow for increased handwashing opportunities.

## Universal Cleaning and Maintaining Healthy Facilities:

- Continued efforts to increase sanitization practices consistent with CDC guidelines.
- Continuous cleaning of building and property.
- Continuous cleaning of all busses. Before and after each trip.

## Contact Tracing:

The district's implementation of health and safety considerations from the CDC will mitigate the risk of spread and exposure. However, the district and community should recognize that we will have the potential for students to be exposed to and possibly contract COVID-19. All students, staff and visitors are temperature screened and wear a mask before entering the bus or school building.

#### Self-Monitor and Hygiene Practices:

- Ask staff, students and families to perform a daily symptoms checklist. If an individual is sick or demonstrating symptoms they will be asked to stay home.
- Continued education and practice of good hygiene and frequent hand washing consistent with CDC guidelines.
- Hand Santizer, hand washing stations and other supplies will be provided to staff and students.

## Special Accommodations:

• If there is a medical reason a child(ren) cannot wear a face covering, parents will need to contact the Academy's front office for additional guidance. Appropriate accommodations will be made for children with disabilities with respect to health and safety.

#### **Continuity of Educational Services:**

- For students who are required to isolate or quarantine, should work with their teacher and building principal to develop a plan for their child.
- For families that would prefer a virtual option, the district will assist families to help them understand the options available.
- Accommodations as necessary or as mandated by an Individualized Education Plan (IEP).
- To ensure there is no interruption of learning in the event COVID transmission rates increase and the community is mandated to stay at home, the district will use the Tiered Learning approach as outlined in the 2020-21 Return to Learn Plan.

In addition to the above CDC-recommended mitigation strategies, we will use ESSER III funding to strategically address pandemic-related learning loss in our scholars, especially those disparately impacted by COVID-19. This will include providing Tier II, small-group tutoring to our students; providing data-driven extended learning time programming in the summer; providing additional social-emotional programming to support students in making a successful transition to in-person instruction; providing our educators with staff development and retention opportunities, and more.


## Funds will be used to purchase supplies and materials for mitigation and prevention.

Multicultural Academy made students' social, emotional, and mental health needs during the 2021-2022 school year a priority by launching Student Support Groups to offer additional emotional and academic support to students who were in the current environment, teaching positive coping skills and referring students to our Multi-Tiered System of Support (MTSS) team as necessary. Technology resources such as Google Classroom and the SAVVAS Platform learning systems. Many teachers provided links for quarantined students to participate in classroom instruction, and students were able to access lessons and assignments via their grade-level learning management system.

Will work additional staffing and expand transportation in support of academic, social and emotional learning as well as mental health. These services will be targeted to all students who are identified during the school year as needing just-in-time interventions (the right support at the right time). Support will begin as soon as the need is identified.
